
About MAS





ENTRY REQUIREMENTS

1. Do you have Grade 12 or equivalent?

You will need a minimum of level 3 in both English and Mathematics If you did Maths Literacy, you would require a minimum of level 4 Students who meet the minimum requirements detailed above will start at the ACCA Knowledge Level. However, students who do not meet the minimum requirements can do a 'Foundation in Accountancyt; a one year qualification which is part of ACCA that will lead to students receiving credits towards the ACCA Advanced Diploma or Skills Level.

2. Do you have a post grade 12 qualification in accounting, finance or business related?
